The Cattewater, a Trust Port, is home to deep-water commercial wharves, the South-West's largest petroleum depots, and various marine leisure facilities.

With the drive for Carbon Net Zero, we have a responsibility to maximise logistical efficiency through all forms of transport, and shipping is at the forefront of that challenge. Plymouth has been awarded "Freeport Status" and sees the development of its marine economy as an important driver in its ambition for growth in local prosperity. In addition, it is fast becoming recognised as the centre of excellence for maritime autonomous development and is now home to the UK's very first National Marine Park, the careful and balanced development of which is crucial to the long-term viability of the port.
